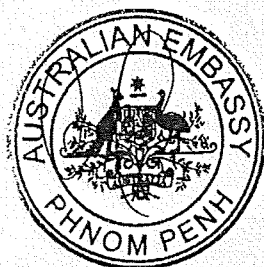

Announcement
On
The revision of entry requirements to Cambodia
The implementation of preventive measure and Quarantine

In order to enhance the efficiency of health preventive measure for response to Covid-19 pandemic and to facilitate the traveler traveling to Cambodia, the Ministry of Health is pleased to inform that the Royal Government of Cambodia has decided to revise the preventive measure and sponsorship mechanisms to facilitate the traveler entering Cambodia for business investor, employee, expert and technician who has a sponsor, general traveler or foreign traveler with Visa A and B or Cambodian traveler with Cambodian passport or foreign passport.

- 1- Business investor, employee, expert, and technician traveling from China, Japan, South Korea, Vietnam, Thailand, America and European Union with sponsorship.
 - a. Before arriving to Cambodia:
Foreign Traveler must carry with document as following:
 - Health Certificate, certified tested negative for Covid-19 issued by competent health authorities of their resident country within 72hrs.
 - Certificate of payment guarantee issued and certified by the Royal Government of Cambodia. To receive the certificate of payment guarantee; foreign traveler must have sponsorship from their employer, CEO, Director of Business Association, Embassy, Ministry, or Institute. etc. The sponsor have to complete the application (online) attached with detail of itinerary and purpose of the traveling not more than 14 days in www.registration.services.gov.kh or www.cambodianinvestment.gov.kh or website of Ministry of Health www.cdcmoh.gov.kh. The application will be reviewed within one or two working day after Ministry of Economy and Finance certified on the sponsorship and Ministry of Health certified on the traveling itinerary then the Royal Government of Cambodia will issue the certificate of payment guarantee with validity of 30 days. The traveler then downloads and print the certificate for traveling to Cambodia.
 - Visa valid in accordance with the law of immigration provided by Embassy of Cambodia or Consul of Cambodia located at their resident Country.

- b. Arriving Cambodia International Airport:
- b-1: Foreign traveler must have:
- Health Certificate, certified tested negative for Covid-19 issued by competent health authorities of their resident country within 72hrs, Certificate of payment guarantee, details of working itinerary, Valid Visa provided by Embassy of Cambodia or Consul of Cambodia located at their resident Country.
 - The foreign traveler holding all above documents is given priority to take Covid-19 test and transport to designated hotel to wait for the result. If the test confirms negative, the traveler is authorized to leave the hotel and travel following their submitted itinerary.
- b-2: The sponsors are responsible for all expenses for those they guarantee including the expense related to traveling restriction measure perform on the traveler during their stay in Cambodia.
- b-3: In case of any foreign traveler tested positive of Covid-19 during their stay in Cambodia, the sponsor must pay to the hospital for the treatment until they recover.
- b-4: The sponsor must cooperate with the Ministry of Health and concern authorities to facilitate the traveling. If any breaching of the sponsorship term and the traveling itinerary, company or institution of the sponsor and the traveler will be responsible in accordance with the Law of Cambodia.
- 2- General Foreign traveler arriving Cambodia must:
- a. Mandatory quarantine at designated area for 14 days.
 - b. Deposit USD2.000 upon arrival at international airport and the deposit cash will use for overall expense for testing and hotel during quarantine period. The remaining deposit case will be returned to the owner within 03 days after health preventive measure.
 - c. Purchase Health Insurance to cover for Covid-19 treatment at USD90 for the package of USD50.000 coverage for the duration of 20 days. The insurance can purchase from FORTE Insurance at (<https://www.foreinsurance.com/covid-19-insurance/>)
 - d. The Ministry of Health authorities will take the sample test on day 13th to finish the quarantine process.
- 3- A foreign traveler holding a diplomatic visa (A) or an official visa (B) arriving Cambodia must:
- a. Implement the announcement 170 dated 05 August 2020 of inter-Ministerial Committee to Combat Covid-19 on the revision of measure for foreign traveler holding a diplomatic visa (A) or an official visa (B).

- 4- Cambodian traveler holding Cambodia passport or Foreign passport arriving Cambodia must:
- a. Mandatory quarantine after taking sample for testing at the designated area for 14 days without any charge.
 - b. Not required to deposit cash and purchase health insurance to cover Covid-19 treatment.
 - c. In case of any traveler request to stay at the designated hotel, all expenses during their stay is under their responsibilities.
 - d. The Ministry of Health authorities will take suspected sample to test on day 13th to finish the quarantine process.
- 5- Use of accommodation and waiting for the result of 1st test for Covid-19 and quarantine:
- a. Cambodian traveler holding Cambodia passport or Foreign passport arriving Cambodia is subject to mandatory quarantine 14 days at designated area and not required to pay for the meal and accommodation. If the traveler request to stay at the designated hotel, all expenses during their stay is under their responsibilities.
 - b. The foreign traveler under sponsorship will be transported to the designated hotel to wait for the result of the first test. After the test confirm negative, they are allowed to self-quarantine and working following their submitted itinerary.
 - c. General Foreign traveler will send to quarantine 14 days at designated hotel and the hotel fee is between USD60 to USD75 per/night. Others expense during quarantine and treatment period refer to the announcement No. 564 dated 11 June 2020 of Ministry of Health on the Price of Covid-19 test, Quarantine and Treatment.

In view of the above, all business investor, employee, expert and technician, general foreign traveler, foreign traveler holding a diplomatic visa (A) or an official visa (B) and Cambodian traveler holding Cambodia passport or Foreign passport to be informed and cooperation to implement this announcement efficiently.

This announcement will implement and effective from 18th November 2020 onward.
